The 2003 school year began with nervous anticipation whether the grand experiment funded by the Bill and Melinda Gates Foundation to create four separate small school would work. Within weeks of the new school year, evidence that the experiment is working surfaced.

Each of the four academies — Arts and Humanities; Health, Environment and Life; Global Studies; and InfoTech — began operating on different class schedules. The bell rings only twice a day: in the morning and at the end of the official school day.

Pride and discipline is returning to the classroom. The school environment is much quieter and cleaner from days gone by.

A new spirit now exists. Perhaps, it isn't really a new spirit but the spirit that has always existed.

During my years at Cleveland High School, there was much talk about the Cleveland spirit. One sensed it in our athletic programs. It was mysterious and yet real. I truly believe the real Cleveland High School spirit transcended beyond athletics and touched the souls of everyone ever connected to our beloved alma mater.

As I move about our community and throughout my career, there is always a special connection when I find someone who either attended or worked at Cleveland. There is an instant bond that is indescribable. No one has ever really defined this spirit in terms that we could all understand and yet everyone felt.

**I**n a few years, our beloved school will be closed and undergo another

transformation. Although our architects will preserve the exterior of our historic school, the building will be rebuilt from the inside out with new systems that will meet the needs of a new generation of Cleveland High School students.

There is much talk about whether this transformation will change what we alumni remember of our old school. I see the physical and academic transformation of Cleveland High School as a reaffirmation that our Cleveland High School spirit is still alive and well. It is an undying spirit that never gave up and always looked forward to the next challenge or opportunity to succeed.

Cleveland High School, led by able administrators and teachers, is making a difference in the classroom. They face innumerable challenges, both academically and financially. They have successfully embarked in a direction to rebuild our school into an institution that we can be proud of. In the ensuing years, they need help to accomplish this mission.

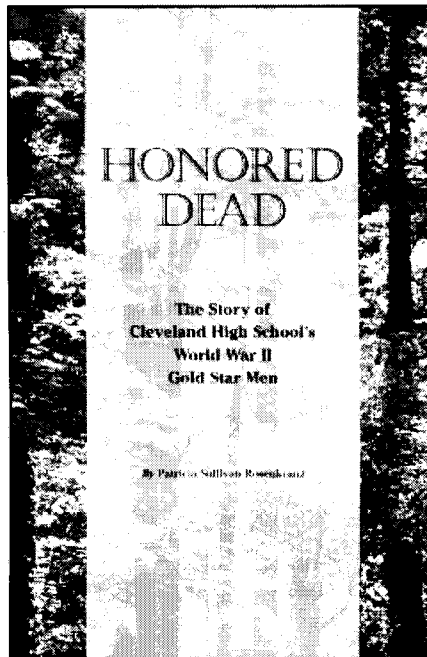

## THE LEDGER

For the year 2003, CHSAA has received net cash inflows of \$6,109 as of Nov. 21, 2003.

The total inflows of \$19,202 consisted of \$16,660 in contributions, \$2,000 in grants and \$542 in other income.

The total outflows of \$13,093 consisted of \$1,366 in administrative expenses, \$7,600 in fund expenditures (\$100 for the 75th-Anniversary Fund, \$3,000 for the Forest Fund and \$4,500 for the Scholarship Fund), \$3,912 in newsletter expenses and \$215 in website expenses.

The total assets consisted of \$53,909 in bank accounts, and there are no liabilities.

## Third-annual CHSAA Golf Scramble

The third-annual CHSAA Golf scramble took place Aug. 8, 2003, at the Fort Lewis Golf Course. Once again we were blessed with beautiful weather and a great turnout. There were 132 golfers, of which 93 were CHS alumni representing 33 classes, 1937 through 1989.

Following the golf was a terrific dinner and raffle attended by golfers and non-golfers alike.

The keynote speaker at this year's dinner was the new CHS principal, Rick Harwood. Mr. Harwood updated the attendees as to the new CHS remodel project and restructuring of school academics.

Team Prizes were awarded to the top four teams in Gross and Net categories. There were also individual prizes awarded for the player closest to the pin on all four par-3s.

There were also prizes for long drive and straight drive.

There were three categories for each of these contests: Graduation years 1937-61, Graduation years 1962-2003 and Ladies from all graduation years.

There was also a putting contest for all players.

This year's Gross Score winner was the Redbird Eagles team. **Jay Turner '75**, owner/operator of Redbird Sports, one of our major sponsors, teamed up with his wife, **Anne (Hidaka) Turner '77**, **Jon Shimada '73** and **Brian Ogishima '71**. Each year, we present a trophy for the

CHSAA Outstanding Golfer of the Year award. This is the individual who has contributed the most by word or deed to the CHS golf program or the CHSAA Golf Scramble.

This year, we had two award winners. Dr. **Charles O. Holmes '61**, captain of the Rex Scott's Eagles team, presented the trophy to Mimi (Scott) Iwami, the daughter of the late Rex Scott, teacher, basketball and golf coach at CHS in the '60s and '70s.

The second award went to **Pat Coluccio '47**, co-director of the CHSAA Golf Scramble since its inception.

The 2003 CHSAA Golf Scramble was "dedicated to those fallen Eagles of Cleveland High School who gave their lives in the defense of our country." CHS alumni killed in action during World War II, the Korean conflict and the Vietnam conflict were honored at this year's dinner. Following the dinner and raffle, the CHS Alma Mater was sung, and **Bernie Moskowitz '58** played "Taps."

# Big changes happening at Cleveland

**H**ello, Cleveland alumni. You all would be very proud of the exciting and innovative changes going on at your alma mater.

As you may have heard from attending the golf tournament, or reading the Seattle P-I on Sept. 4, 2003, or speaking with alumni in the know, Cleveland High School is on the cutting edge of a high-school transformation.

This school year, we became the first Seattle high school to establish small learning communities, or academies, for all students in all grades. Our goal is to create a more personalized learning environment that will help all CHS students be academically successful and be prepared for life after high school.

We will build on Cleveland's long tradition of being a place that has always felt like family.

**W**e have chosen four academies that are theme-based, which we believe will help students to find their learning experience meaningful and relevant.

All students will be in one of the four academies for all classes during all four years they attend Cleveland.

Our four academies include:

- InfoTech, with a focus on learning about and using technology;

- Global Studies, where students will explore world cultures and world affairs;

- Health, Environment and Life, which will emphasize the study of environmental and health sciences and careers; and

- Arts and Humanities, where the pursuit of the visual and performing arts will be the primary theme for all learning.

In all four academies, students also will take all the core classes required to graduate from high school and be prepared to attend college.

**A**t the same time as being the cutting-edge high school for our transformation work, we also are in the unique situation of designing plans for a major renovation of the CHS

building. No other existing high school that I know of has had this opportunity to redesign its academic program and its physical plant to match.

The redesign of the CHS building is truly a thrill and offers the likelihood that we will have the best high school facility in all of Seattle. The only drawback is that the construction phase of the project will not begin until June 2004 and be complete until summer 2007.

The School Design Team committee has been meeting every other week since last fall, and the design is nearly complete. Alumni representatives have participated on the committee, and presentations have been made at the golf tournament awards dinner and at a recent Alumni Association board meeting.

My impression is that alumni who have seen the designs and hear the presentations are impressed. I expect that when the project is completed, you also will be very proud.

Many of the historic features of CHS — like the original building façade and the entry arch on South Lucile Street — are being preserved, and there will even be an opportunity to purchase items, like auditorium seats, before the demolition begins.

In the new gymnasium and commons building to be located on the northeast corner of the CHS property, there will be a room designated for the Alumni Association to use for office and meeting space. This should help strengthen the relationship between the Alumni Association and the current staff and students of Cleveland.

**T**here are many other exciting activities and events that make up the life of the Cleveland Eagles of 2003-04. I will continue to keep you informed through future columns in your CHSAA newsletter.

In the meantime, thanks for all your interest and support. Our students and staff appreciate the strong connection between past and present that makes life as a Cleveland Eagle a meaningful experience for all of us.

## RENOVATION update

The architects have moved forward with completing the early design effort that culminated in its presentation to the Seattle School Board on Jan. 7, 2004.

One of the many features of the design project is the development of new courtyards that open up the school to the neighborhood along 15th Avenue South.

The back of the school then will become the primary entry onto the site, which will better address the communities from where most of the students arrive from.

The project team is planning to start construction of the waterline work along 15th Avenue this summer. This work is required by Seattle Public Utilities to increase water flow to the fire hydrants serving the school.

By planning to complete this work prior to the actual school construction, which is scheduled for June 2005, it will have less impact on the neighborhood facing the school, along 15th Avenue.

Upcoming activities include identification of historic elements within the 1927 building that the design team will reincorporate into the new modernized facility.
