A Piece of History Preserved of Good Ole' Cleveland High School

My name is Jackie Jones Hoggatt and I graduated from Cleveland in 1960. I attended the UW and became a teacher, moved to Kent where we lived for 45 years, raised my two children, recently followed our daughter and grandchildren to Gig Harbor where we live now. We also spend our winters in Palm Desert but didn't miss all the snow as we come home for Christmas.

On the day of our 45th Cleveland reunion, my daughter called to ask me what the name of my high school was. They lived in Kennydale and remodeled that house; so, my son-in-law liked to visit a place in Seattle that sold old stuff from torn down homes. On that particular visit that day he found the bleacher seats from the remodel of Cleveland High School. He bought about 1000 feet of the seats and brought it home. They had used seats from Bainbridge High remodel for their floor boards in their Kennydale house. They had no idea what they would be doing with the Cleveland seats. Soon after this, they purchased a home in Lakebay on the Key Peninsula near Gig Harbor. Soon the remodeling began again.



Once they finished their new kitchen they were ready to complete new floors throughout the rest of the house. The bleacher seats are nice and thick, straight and about 20 feet long. The sides are cut so they butt together. They require little maintenance. Once they are down, they are nailed with some old, strong nails that are sunk into the wood. Of course, the old bolt holes are still visible. They've chosen to leave those exposed. Our 6 year old grandson loves that as he puts flags in the holes when playing with his "army men" or Star Wars Legos.

I think it's weird but they love it this way. These boards were very clean and only a little sanding was required to get the gum and words off. They had leftover boards so the carpenters planed more down to use to make their arches around the doors, do the stairway, and fix a coat area with bench in their entry. I've included photos of the floor, the entry, and the arch. Pretty neat to know we have a little personal history in their home, although I don't remember ever sitting in the bleachers in the gym. Not even sure if the seats were in the old school or the addition of the newer gym built after I left Cleveland. They did get a framed photo of the school in the purchase of the seats but it has been lost in the move and remodeling. If it ever surfaces, I understand it may be the lost photo that hung in the old office and we will donate it back to Cleveland. I hope you enjoy my story and the photos of a strange twist of fate.

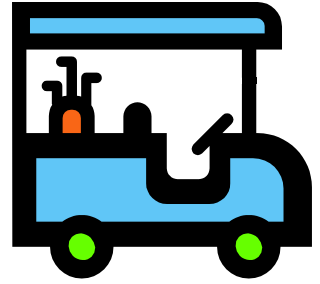

Three months after graduating I joined the USAF and made military medicine a 25yr career. After retiring in May 91 I went back to college and earned two degrees, one of which is in Medical Admin. In Feb 98 I totally retired (age 52 and two months) and have been playing ever since. went in the AF in Sep 1965 and got my wish: to be a medic, which I was my entire career. I advanced quickly and became supervisor of junior medics in various areas of the hospital ranging from Emergency Services, to Clinics, and Nursing Units.

Stewardship Report to Members

It is remarkable that the alumni association is now entering our 14th year of serving our membership and our alma mater. At our Annual Meetings each year, the board reports to our membership on the activities of our organization and listens as our members share questions, concerns, and ideas for making our organization better. However, these annual sessions only focus on what has transpired in the past year and a look toward the next year.



At the close of 2008, we had an opportunity to examine our financial and membership records spanning the past thirteen years since our alumni association was founded. The result of this joint examination is a new report, "Stewardship Report to our Membership." This nine page narrative report along with the fourteen pages of statistical and financial documentation is being posted on our alumni association's web site at <http://www.clevelandalumsea.org>.

Here are some interesting facts derived from this examination of our donor history, our membership base and financial record:

- ⇒ For the ten year period from 1999-2008, we received \$193,348 in donor contributions or an average of \$19,33 per year.
- ⇒ During the same period, there were 1,277 individual member donations.
- ⇒ 831 of the 1,277 donors gave less than \$99 or \$24,756 (12.5%).
- ⇒ There were 444 Eagle 100 Club members who donated at least \$100 or more for a total of \$168,591 (87.2%).
- ⇒ Using our newly adopted "Levels of Recognition" classification; we have the following results:

219 Bronze Eagles	\$27,545
151 Silver Eagles	\$44,888
46 Golden Eagles	\$29,965
26 Platinum Eagles	\$39,253
3 Diamond Eagles	\$16,940
1 Special Honors	\$10,000
- ⇒ During the past ten years, we raised \$10,000 from our Golf Tournament and \$12,000 from a State matching grant for our Scholarship Endowment Fund. It now totals \$30,055 and growing. We have awarded 33 scholarships totaling \$61,595.
- ⇒ We just completed our Certificate of Deposit "Ladder of Investment" with \$64,458 invested in 12 individual CD's.
- ⇒ When we examine our aggregate expenses vs. revenue for the entire thirteen years. We posted donor contributions of \$270,683. After deducting for expenses (\$168,482) and our current bank balance is (\$104,724); we end up with a net positive difference of \$2,523 or 0.93% of our total donor contributions.

(Note: From 1996-1998, detailed donor records are not available; however we received \$27,895 in total contributions during this period).

- ⇒ Our administrative expense approximate 7% and 9% if we include the board related expenses; compared to many other nonprofit operations, we are well within acceptable national standards for charitable organization.
- ⇒ On the operational side, scholarship program (37%), Alumni newsletters (37%), Programs/ Special Events (15%), and Web Site (2%) take up the balance of our expenses to date.

Our report also summarizes where our giving is coming from in terms "class years" and "by decades". Take a look at the supporting documentation for this information.

When we look at our membership data for the same period; our current membership rolls with valid addresses totals roughly 7,800+. However, when you breakdown the details on where our membership resides we find some very interesting data.

- 99.83% or 7,858 members live in the good ole U.S.A.
- 93.6% or 7,359 reside on the West Coast States of Alaska, Washington, Oregon, California and Idaho.
- 87.11% or 6,845 members reside in the State of Washington
- 27.80% or 1,903 members still reside in the three zip code area that serve as the catchments area for Cleveland High School (98108, 98118, and 98144)

At the close of 2008, we engaged a CPA, Jerry L. Clark '61 to conduct a financial review of our records for the past three years. In a letter dated February 17 to the Board of Directors and Alison Sing, he reported the following:

1. I was very pleased to find the financial records in excellent order. Almost every item of expenses and donation received was properly documented and filed appropriately. Your level of detail is unusual and is to be commended.
2. I believe the Association has been well-served by Alison Sing as its Treasurer and steward of the financial process.

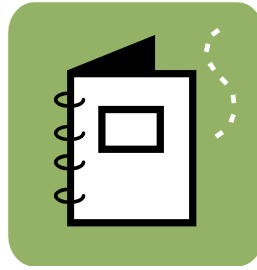

Board Reference Notebook – A new online version available (Summer 2009)

In the past thirteen years, our board and officers have labored quietly and efficiently to build a functional organization that strives to fulfill the mission of our organization and be a good steward of our members' monies.

In May 2005, when we loss our long-serving treasurer, Terence L. Wong '58, we realized that many of our operational procedures had not been written down nor had we cross-trained anyone to assume critical positions within our organization. This tragic wake-up call spurred me to begin organizing a board manual not only to educate our board members about our organization's operation but to develop a tool that interested members of our alumni association could learn about the history and the commitment made by past board members and officers to grow our organization.

Since, I began this process the "board reference notebook" that I warmly refer to as a "work-in-progress" has been updated three times. With each annual election of board members this nearly 400 page notebook has been given to each new member to help them understand the inner workings of our organization.

What is new this time is that the entire "Board Reference Notebook" has been converted into a PDF document (Portable Document Format) that is easily accessible to all alumni members. This document is organized into 31 tabs and every element of our operation is detailed and featured under one of these tabs.

Dick Korpela named CFO of the Year



Lynden Executive Vice President and CFO Richard "Dick" Korpela was named CFO of the Year in the *Puget Sound Business Journal's* annual event. Nearly 50 chief financial officers were nominated for the award, and over 500 people attended the awards ceremony where Dick won in the category of "large, private" businesses. He was honored at a banquet February 28 in Seattle with his wife Harriet, two sons and several Lynden co-workers in attendance (see photo above).

Dick joined the company in Lynden, Wash. in 1975 during construction of the Trans-Alaska oil pipeline. Lynden had about 300 employees then in contrast to its more than 2,000 today.

"Dick's steady guidance and tireless hard work during the past three decades has allowed us to grow from a small Alcan Highway trucking company to an international transportation and construction company," says President Jim Jansen. "We are

grateful for Dick's leadership, hard work and integrity."

The judges were looking for financial performance, but they also wanted someone who contributes to the company's strategic direction. Dick was among the few elite financial strategists chosen. In Dick's nomination from his colleagues at Lynden, he was recognized as a financial steward, strategic contributor and civic leader.

Dick graduated from Cleveland High School in Seattle and worked his way through the University of Washington supervising fellow students at the mailroom of the Federal Reserve Bank in Seattle, pumping gas, delivering mail at Christmas and even driving a taxi 84 hours per week one summer. After entering the U.S. Army in 1967, he completed Officer Candidate School and was shipped to Vietnam. There he managed the army's largest direct support repair parts supply installation by day and led patrols by night as a platoon

leader. He returned from Vietnam with the Bronze Star with Oak Leaf Cluster and enrolled again at the University of Washington to earn his Master's of Business Administration (MBA).

He joined Lynden Transport Inc. in 1975 as controller and in three years had become the CFO, a position he still holds today. Lynden has grown tremendously during Dick's tenure. According to Jim Jansen, Dick's responsibilities have grown along with the company. He is directly or indirectly responsible not only for finances, accounting

and taxes, but legal, human resources, employee benefits, training, risk management and strategic planning. Dick started Lynden's first information technology capability as we know it today and continues to oversee IT and its advancements.

Dick and Harriet make an annual trek south to Mariner's spring training with their two grown sons. When the boys were young, he coached youth baseball and attending UW sporting events has always been a favorite family pastime.

"Not only is Dick a great CFO, he is a tremendous and patient mentor. He has trained and inspired several of us and built a very strong team for Lynden," says Everett Billingslea, vice president, administration and legal affairs. "Dick will be retiring this year, and the CFO of the Year Award is a fitting recognition in the final year of a remarkable career."
