CHSAA GOLF TOURNAMENT = MONEY TO SCHOLARSHIPS

A WONDERFUL CHALLENGE AT DRUID'S GLEN GOLF CLUB

It was an early Saturday morning in August as 44 intrepid golfers made their way out to Druid's Glen Golf Course located in southeast King County to play in the Cleveland High School Alumni Association's 9th Annual Golf Tournament.

Draped in the shadow of Mt. Rainier, the 7,146 yard, up-scale public course is carved out of 230 acres of second growth forest and features sculpted-bent grass tee boxes, fairways and greens. Awaiting our golfers are over 60 strategically placed sand bunkers and nine lakes. This course was designed to challenge golfers of all skill levels.

Upon arriving, the golfers were heartily greeted by our dedicated golf committee headed by Barbara VanEynde '71 who began registering the teams for the early 8 AM reverse shotgun start.

As with every golf tournament, there are some basic tools one needs to give their team that ever slight advantage over their competitors. Selling fast were the "Magic" game tickets offering each golfer three Mulligan's, an entry into the putting contest, and the opportunity to win "Two Weekday Rounds of Golf at Druid Glen". Another must-have golf tool was the "Licorice Rope" and these were selling just as fast as the game tickets. Once on the green, the Team can elect to use a length of "Licorice Rope" to save a putting stroke. Even armed with these stroke-saving measures, the golf course was unforgiving and challenging for even the best players.

This year's contingent of 44 golfers included thirty-three alumni (58.9%) representing four decades - 50's (4); 60's (14); 70's (12); and 80's (3). Although the majority of the golfers were men, we were graced with two women this year, Roxanne Jonson '84 and

1953 CHAMPIONSHIP BASKETBALL TEAM

All five starters on Cleveland's 1953 championship basketball team pictured above, still get together for golf and reminiscing about their days at Cleveland. I was a junior that year, Dick Minice was a sophomore, and Dan Niksich, Sherman Swanson, and Phil Rich were seniors. Dick Beers, who was our "sixth-man," passed away earlier this year. Ken Pinyerd is also deceased. Dick Stuns, Ronnie Wayman and Bob Fossetti were also part of the team. The coaches were Rex Scott and Ed Landon.

We were a fairly big team for that era. Four of us were about 6-3 and Phil was 6-7 and very strong. Dan Niksich had a great shot and did most of the scoring. Dan held some city records for a while, and I think he still may hold the record for shots attempted. As Dick Minice likes to say "Dan plays golf like he played basketball---he takes a lot of shots". We represented Seattle in the state tournament at UW's Hec Ed and won a couple of games but we were knocked out by Renton, the eventual state champions that year.

We had some good athletes at Cleveland in that time frame. We won championships in baseball in 1952, 1953, and should have won it in 1954. We won the league easily and then had to play West Seattle, the second place finisher in a playoff at Sick's Stadium. All we had to do was win one game and they had to beat us twice. Darned if they didn't, by virtue of some of the luckiest breaks ever seen in baseball. As you might tell, we are still bitter after 57 years.

Jerry Hammack and Ken Kane, who played on those championship baseball teams, host a barbecue/golf

outing at Alderwood Golf Club on Hood Canal each year, and any old grads of that era are welcome to join us (except for West Seattle grads).

As you may have noticed, there is no mention of football. In the three years I played, we won a grand total of two games. I often think that if we had a system then, like we have today, where schools play each other based on enrollment, we would have been more successful. Back then the schools making up the city league were Queen Anne, Ballard, Roosevelt, Lincoln, Garfield, Franklin, West Seattle and Cleveland. Most had enrollments four times the size of Cleveland, which makes our basketball and baseball championships even more impressive. For whatever reason, larger schools always seem to do better in football, probably because 15 to 20 good players are required. In basketball, if a team can come up with a few good players, they can compete. In baseball, if you have good pitching, like we had with Dick Minice and Don Mozzone you can also compete. If any of the players from Cleveland's 1937 football championship team are still hanging in there, they should be extremely proud of doing something that no other Cleveland team has been able to do in 73 years.

Finally, the 1953 basketball team would like to challenge the 2009 Cleveland state champion girls basketball team to a game. However, the game would have to be half court with one minute quarters, and the Alumni Association has to pick up the tab for keeping an Aid car on the sidelines.

A MESSAGE FROM COACH MARTIN

As head football coach of the Cleveland Eagles I would like to thank the Alumni for their continued support and dedication to CHS academics and athletics. We have had some success this season finishing with a one and eight record. That is an improvement over 2009.

Our academic standard as a football team has improved significantly over last year, but what does that have to do with athletic success on the football field ??? Academics are important because our players must meet district standards to be eligible to play. In 2009 25% of our players were eligible to play. This year about 70% of our players were eligible. That is an accomplishment I am proud of, but we still have a long way to go. A large part of this success is the result of our in-and-out of season study hall.

Yes, the Alumni has been supportive, but I am writing to ask for even more support for our football program. With improved financial help we can offer more students the opportunity to attend the highly desired football camps, and that in turn gives them the incentive to improve academically. CHS HONORED DEAD — KOREA

A Review of History

In 1945, at the end of World War II, the Allies divided Pacific territories that had been controlled by the Japanese. Korea had been under Japanese control since 1910 and in 1945, following the Japanese surrender, the country was divided along the 38th parallel. The United States troops occupied the southern part of the peninsula and the Soviet troops (Russia) occupied the northern part. Two different forms of government resulted in many conflicts. In 1948 failure to allow free elections in North Korea intensified the problems. A Cold War persisted with border skirmishes and raids being conducted from both sides of the 38th parallel. There had been a movement towards reconciliation and negotiations but on June 25, 1950 the North Korean troops invaded South Korea.

The United States and other United Nation countries sent troops to aid the South Koreans. The Soviet Union and Communist China - The People's Republic of China - aided North Korea. With Communist China entering the conflict military tactics from W.W.I and II were put into action, with infantry and air bombing raids. These campaigns continued from July 1951 until August 1953 when a 2.5 mile demilitarized zone was set as a buffer zone between the two Koreas. A stalemate was declared.


The Korean conflict was not identified as a "war" since the United States Congress did not officially make a Declaration of War. The confrontation was described as a Police Action. In the U.S. it is often referred to as the Forgotten War. Other nations have different terms to describe the event. As a stalemate, many issues in the Korean War were not detailed as had been done in both world wars.

Whatever the end result, the sad fact exists that during this conflict, as well as in Viet Nam, American boys registered for the draft, went to foreign countries for service, and did not return. Included in those not returning are seven former CHS students whose names are now on the rock in the CHS Memorial Forest. I was able to find the information on five of these men. We have not yet found information on Ray Oleson and Gene Modenese.

I knew Ray Oleson. He was a wonderful young man - Class of 1949. He was a leader in school, friend to all, and he joined the Air Force during the Korean conflict. Unfortunately he was killed in a training crash but I am not sure where he was based at that time. We would appreciate hearing from friends who may have knowledge of the event. In addition, if any veteran would care to share knowledge of your time in service, during any war we would appreciate hearing from you.

There are obvious conflicts of information on military research websites. The best information we have acquired on our Korean War casualties is presented on the adjacent page.




